Biography

Edimansyah Abdin obtained his PhD from Science University of Malaysia in 2009 and is currently a Principal Biostatistician at the Institute of Mental Health, Singapore. He has over 15 years of experience in survey design, and use of advanced data analysis techniques in mental health research, and served as the Principal Investigator for two National Medical Research Council (NMRC)- funded research grants, to investigate the performance of generic preference-based measures of health-related quality of life, validate the disability assessment tools, and develop mapping functions in schizophrenia, depression, anxiety, and diabetes samples. He led data analysis for nationwide mental health-related surveys such as the Singapore Mental Health Study (2010, 2016), Well-being of the Singapore Elderly Study (2013, 2023), and Mind Matters Study (2021). He has contributed to the development of mental health instruments such as the Positive Mental Health Instrument, iWorkHealth, and Case Management Quality of Case Scale, and has been actively involved in the development of mapping functions of health utility values for Cost-Utility Analysis. To date, he has over 300 publications in peer-reviewed journals and served as a reviewer and associated editor for international journals.
