## Biography

A/Prof Mythily graduated from the Lady Hardinge Medical College, India. She received her PhD in Gambling Studies from Monash University and is currently Assistant Chairman Medical Board (Research) and Lead Investigator of the Programme of Mental Health Policy Studies at the Institute of Mental Health (IMH). She has a teaching appointment at the Saw Swee Hock School of Public Health, National University Singapore. She is also a consultant with the Ministry of Health, Singapore.

She has worked in the field of mental health for more than 15 years and her main academic and research interests include psychiatric epidemiology, psychosis and addictions. She has led several nation-wide studies – the first and second Singapore Mental Health Study, surveys that established the prevalence of select mental disorders in the adult population of Singapore; and the two Well-being of the Singapore Elderly study, a survey among older adults that aims to establish the prevalence, risk factors and cost associated with dementia in Singapore. Till date she has over 500 publications in peer-reviewed journals and an H-index of 78. She is a reviewer with many international journals and is on the editorial board of a number of peer-reviewed journals in the field of mental health.

## Translating Research/Innovation Into Healthcare

### Public health impact of mental disorders in Singapore

- Establishing the prevalence of mental disorders including drug use in Singapore's adult and older adult populations that has aided formulation of policy and development of services. The SMHS 2016 established the prevalence of schizophrenia in Singapore and the cost of mental illness both of which were highlighted by our President in her social media pages.

### Understanding of stigma towards mental disorders

- Examination of mental health stigma from various perspectives including that of patients with mental health conditions and their caregivers that has helped anti-stigma efforts in Singapore.
- Was the co-lead of a study done on university students in Singapore to examine the effectiveness of an education and contact based intervention to reduce stigma towards people with depression and improve mental health literacy and help-seeking in university students. This study was adapted by National University of Singapore to run their highly successful Are U OK campaign that was aimed at improving mental health awareness and reduce stigma across the university.
- Established mental health literacy and stigma towards mental disorders in the Singapore population.

### Community mental health services

- Led two large implementation research studies working closely with Voluntary Welfare Organisations which involved implementation of programmes to (i) improve cognition and quality of life in people with early onset dementia using work as therapy and (ii) improve mental health literacy across secondary schools in Singapore. The partnership led to improvements in the programme and sustained funding.
- Evaluated a community-wide initiative funded by the Tote Board – The Gifting Circle approach to improve the mental health of Singapore's youth.

### Understanding of schizophrenia

- Study into the genetic causes of schizophrenia as part of the Translational Clinical Research Programme of Psychosis that has led to the publication of several impactful articles as part of the Schizophrenia GWAS consortium.
- Conducted several studies with the early psychosis programme to understand outcomes, factors affecting outcomes and role of case management and peer-support in psychosis.
